NOTICE TO PARENTS / GUARDIANS OF STUDENTS

Your son/daughter is enrolled in a mobile classroom that contains texts, equipment, and many other materials owned by the South Dakota Department of Career and Technical Education. As such, these items are classified as school property. Your son/daughter will use and be responsible for intentional damage or loss of such property. This is in accordance with South Dakota Law 13-32-5 stated below:

Law 13-32-5:

Injury to school property is grounds for suspension or expulsion - liability of parents for damages.

Any student who cuts, defaces, or otherwise injures any schoolhouse, apparatus, or outbuilding thereof, is liable to suspension or expulsion; and, on the complaint of the teacher to any member of the School Board, the parents or guardians of such student shall be liable for all damages.

This does not mean the student must repair or replace any piece of equipment that fails when they are using it. It means that the student is responsible for the loss of tools or texts assigned to that student. It also means that the student is responsible for any damage to the classroom or equipment that is determined to be caused by abuse or intentional damage.
